In the May 2023 school board elections in McKinney, two of the three pro-Christian values candidates lost by approximately 50 votes each out of an average of only 2000 votes cast!

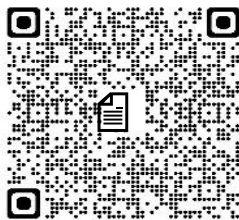
It has been estimated that if just 10% more informed Christians voted their Biblical Values, the Church would have the ability to influence our culture again.

Christians are not actively engaged in their local government. Most Commissioner Court meetings are empty.

For a year and half, our Commissioners Court refused to put Election Integrity on the agenda despite repeated petitioning from the public.

We've discovered 17 problems with Elections. See our report below:



In Collin County, we have found that when you educate the public and make them aware of the problem, they show up.

On August 28, 2023, the Commissioners Court finally added Election Integrity to their agenda.

CDF gathered 40 speakers and filled the room. Most of these were Christians.
